## INTERNET SITE VISITOR PERSONAL DATA PROTECTION AND PROCESSING CLARIFICATION TEXT ("Clarification Text")

#### 1. GENERAL DEFINITION

Within the scope of the law, personal data encompasses all types of data related to an identified or identifiable natural person. Special Category Personal Data, a specific type of personal data, includes information about race, ethnic origin, political opinions, philosophical beliefs, religion, sect, other beliefs, clothing, association, foundation or union membership, health, sexual life, criminal convictions, and security measures, as well as biometric and genetic data. The processing of personal data involves any operation or set of operations performed on personal data, such as obtaining, recording, storing, retaining, altering, rearranging, disclosing, transferring, taking over, making it obtainable, classifying, or preventing the use of such data, whether through automatic or non-automatic means, provided that it is part of a data recording system.

#### 2. DATA CONTROLLER

Your personal data may be processed by Kuark Endustri A.Ş. ("Data Controller"), in its capacity as the data controller, within the scope described below, in accordance with Law No. 6698 on the Protection of Personal Data ("Law").

### 3. COLLECTION OF PERSONAL DATA, LEGAL REASONS, AND PURPOSES OF PROCESSING

Your personal data may be collected by the Data Controller in accordance with the Law, depending on the services provided by the Data Controller and the commercial activities carried out by the Data Controller. This data may be collected through automatic or non-automatic means, verbally, in writing, or electronically.

Your collected personal data may be processed by the Data Controller for the purposes detailed below, in line with the basic principles set forth in the Law and within the conditions (legal reasons) for the processing of personal data specified in Articles 5 and 6 of the Law. You can review the details of the personal data that may be processed by us, how they are collected, and the purposes for processing them in the tables below.

# 4. PARTIES TO WHOM YOUR PERSONAL DATA IS TRANSFERRED AND PURPOSES OF TRANSFER

Your personal data may be transferred by the Data Controller to the domestic and international recipient groups listed below, limited to the purposes mentioned above, in accordance with the basic principles set forth in the Law and the conditions for the transfer of personal data specified in Articles 8 and 9 of the Law.

### 5. YOUR RIGHTS AS A PERSONAL DATA OWNER UNDER ARTICLE 11 OF THE LAW

We inform you that as data owners, you have the following rights under Article 11 of the Law:

- To learn whether your personal data has been processed,
- To request information if your personal data has been processed,
- To learn the purpose of processing your personal data and whether they are used in accordance with the intended purpose,
- To know the third parties, both domestic and abroad, to whom your personal data has been transferred,
- To request the correction of your personal data if it has been processed incompletely or inaccurately and to request the notification of this correction to the third parties to whom your personal data has been transferred,
- To request the deletion or destruction of your personal data in the event that the
  reasons requiring its processing no longer exist, even though it has been
  processed in accordance with the Law and other relevant legal provisions, and
  to request the notification of this deletion or destruction to the third parties to
  whom your personal data has been transferred,
- To object to a result that has arisen to your detriment by analyzing the processed data exclusively through automated systems,
- To request compensation if you suffer damage due to the unlawful processing of your personal data.

If you submit your requests regarding your rights by the methods specified below, your request will be resolved free of charge within the shortest possible time and no later than thirty days, depending on the nature of the request. To exercise your rights, you can fill out and sign the relevant person/data owner application/request form, which can be found at <a href="https://kuarkendustri.com.tr/">https://kuarkendustri.com.tr/</a> or physically obtained from the Data Controller's address, and submit it in one of the following ways:

- By hand, with documents that verify your identity, to the secretariat at the Data Controller's address at Egemenlik Mah. Aydınlar Cad. No:47 İşıkkent Bornova/İZMİR,
- By sending it to our address via a notary public or registered mail.
